## 3.0 PROGRAM UPDATE

Readiness – work is commencing on finalising Test Strategies, developing test workbooks and test plans. AEMO are engaging industry on the accreditation and registration processes and timeframes

The next IEC meeting is on Monday, 8 May and the next Executive Forum is on 22 May.

AEMO will commence the As Built Procedure Consultation mid-May, which will encapsulate the meter churn outcomes.

The Systems Working Group had a Forum on the SMP Technical Guide, covering functionality and new connectivity. Feedback will be sought on these functions.

The testing environment is now open for the first procedures which were finished last year. A pre-prod environment is available for the EN/MC changes. These are in the FTP server environment and AEMO will release a patch on 22 May, which will capture changes that go out in the mid-May consultation pack and will be released for testing afterwards. The API environment will be released in early June. Participants will be able to connect and conduct connectivity testing to the SMP server with further functionality becoming available during this time frame. The co-ordinated industry testing phase will commence in August.

\*\*Action: AEMO to produce a forecast list of functionality availability throughout Phase 2 testing (June to mid-August).

There is a Readiness Information Session on 9 May and participants are encouraged to email AEMO if they have queries or discuss items in more depth.

Testing will occur in three phases:

- 1. EN/MC currently occurring.
- 2. Connectivity testing commencing June.
- 3. Market testing commencing August.

Participants were encouraged to obtain their login for testing and investigate the tools and functions that are available. *Action: B. Healy to supply exact date for availability of test environment (early June).* 

The Transition and Cut Over Plan should be complete by mid-June. The focus will be on customer impact, along with planning for an ideal treansition (a "utopia" transition) before



conducting contingency planning. *Action: B. Healy to advise on when R36 Schema will be available in the testing environment.* 

Translation Tool – AEMO completed an assessment requested by the IEC an determined that the development of a ranslation tool is not feasible at this stage.

Transition and cut over will likely have jurisdictionally focused plans.

AEMO has sent out a letter from our CEO to each particiapnts CEO's encouraging all to be involved in the program, specifically in the readeinss activities and thanking those participants who've been participating to date.

AEMO will also engage an external group to undertake an independant audit on participant's readiness during May/June and also in September/October 2017. The scope of the audit is currently be developed. Participants were keen to know if they would be given access to this report. AEMO will provide more information on the audit at the next PCF in late May 2017.

#### **4.0 OTHER BUSINESS**

D.Cornellius from the Victorian Government informed the PCF the government will release a decision on the consideration of meter types in Victoria week commencing Monday 8 May. The draft of the Order in Council will be available week commencing Monday 22 May.

D. Ou (Endeavour Energy) – queried Package 3 being delayed due to meter churn. There is a query if changes are required to the procedures, or is it just clarification of the process that is required. Details will be distributed next Friday, 12 May.

B2B WG are recommending to the IEC that an 'as built consultation' does not need to occur.

Next PCF will be Thursday, 25 May 2017.
