

TIMETABLE FOR THE 2017 RESERVE CAPACITY CYCLE FOR THE WESTERN AUSTRALIAN (WA) WHOLESALE ELECTRICITY MARKET

The 2017 Reserve Capacity Cycle is for Reserve Capacity required between 1 October 2019 and 1 October 2020. Note that this 2017 cycle has been deferred, so will be completed in the 2018 calendar year.

Wednesday	21 March 2018	5:00PM	Market Participants advise AEMO how many Capacity Credits each Facility will provide and of any Long-Term Special Price Arrangements to be accepted (if auction required)
Friday	23 March 2018	5:00PM	<ul style="list-style-type: none"> • AEMO assigns Capacity Credits (if Reserve Capacity Auction is required). • Market Participants may apply to AEMO for a recalculation of the amount of Reserve Capacity Security required to be held for a Facility (applications may be received after this date/time).
