Notice to Participants on AEMO decision to approve amendments to Retail Market Procedures (NSW/ACT) (RMP (NA))

This notice advises Gas Market Registered Participants that consultation under the expedited Procedure change consultative process prescribed under Rule 135EF of the National Gas Rules (**NGR**) concluded on 31 January 2017 for:

- **IN038/16 (NSW-ACT Report Timing)**

As required under Rule 135EF of the NGR, Gas Market Registered Participants and other interested parties were invited to submit comments to AEMO on the Impact and Implementation Report (IIR) for each proposal.

Attachment B of this notice sets out the consolidated feedback relating to the RMP (NA) that AEMO received during this consultation phase. These include stakeholder comments, AEMO responses and, based on those responses, indicate where the feedback resulted in further amendment to the RMP (NA) versions issued with the IIR.

Having considered each proposal and the issues raised in the consultation, AEMO has made further amendments as per the submission received to the RMP (NA) in the forms published in this notice. The target effective date for the changes described in Attachment A is **5 April 2017**.

Marked-up and clean copies of the new versions of the RMP (NA) pertaining to the changes will be published on the AEMO website prior to the effective date.

8.12 AEMO TO PROVIDE INFORMATION (STTM NETWORK SECTIONS)

8.12.1 AEMO TO NOTIFY USER

- (a) By 11.00 am on *gas day +1*, AEMO must notify each *User* in a *network section* of the following information for that *network section* for the *gas day*:
- (i) the *User's STTM distribution system allocation*;
 - (ii) each component of the *User's STTM distribution system allocation*; and
 - (iii) ~~the *User's apportionment percentage*; and~~ [Deleted]
 - (iv) *metering data* for all *daily metered delivery points* for which the *User* is responsible.
- (d) AEMO will provide to a *Participant* information related to:
- (i) *net section load*;
 - (ii) *apportionment percentage*;
 - (iii) *non-daily metered delivery points*;
 - (iv) ~~*metering data*;~~ [Deleted]
 - (v) energy values for those active *non-daily metered delivery points*; and
 - (vi) total injection data.

The format and timing of this report will be agreed by AEMO in consultation with *Participants* and the information would be current as at the time and date that the data is provided.
