# 5.1 Progress and Deliverable update

- The SAPS component remains amber due to internal testing, and performance updates to CDR.
- Industry testing is on track to commence as planned with the scope and approach being addressed via the Industry Testing working group (ITWG).
- The proposed LCCD procedure effective date is now 1 November 2023. This is subject to an industry consultation.
- AEMO advised that the Markets Portal is now accessible on AEMO's public website and MarketNet.

Mark Riley – AGL	We need to contemplate or something like a full update of MSATS sets or as close to a full update as part of going live rather than just doing it when we get to it or as a customer changes. The dynamic has shifted now and everyone's going live on the one date. I suggest flagging that is maybe worth conducting a workshop with all the right people to work through it and with something like BT updates.	AEMO will consider the scope of industry testing to support a November release when the procedure consultation for metering exemptions and LCCD are confirmed with an effective date.
